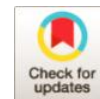




An Investigation into The Role of Renewable Energy Technologies in Energy Security and Sustainable Economic Growth: A Case Study of Iran

Denmark, a pioneer in wind energy, now sources over

50% of its electricity from wind power, allowing it to reduce exposure to fuel price fluctuations and ensure stable electricity costs for its citizens. China, facing enormous energy demand, has massively invested in solar and wind technologies not only for environmental goals but also to reduce reliance on coal imports and enhance energy self-sufficiency.

Application in the Iranian Context

Iran's dependency on natural gas and oil for electricity generation has created a fragile energy structure, especially in the face of seasonal consumption peaks and export commitments. Renewable technologies—particularly solar—offer a distributed, scalable solution that can be implemented in both urban and remote areas.
